**THE MEETING OF THE CRAWFORD COUNTY BOARD OF COMMISSIONERS  
WAS CALLED TO ORDER AT 9:00 A.M.**

**INVOCATION GIVEN BY MR. BOBBY BLASINGAME**

**Mr. Braswell made a motion to allow Mr. Spillers to participate in the Called Meeting via telephone. Mr. Thomas seconded and the motion carried 4-0.**

**AGENDA APPROVAL**

Mr. Chapman asked for a motion to approve the agenda. Mr. Blasingame made the motion to approve the agenda. Mr. Braswell seconded and the motion carried 5-0.

**FIRST ON THE AGENDA**

**New Business: *Health Planning Associates – Group Health Insurance Renewal.***

Mr. Kelly stated that the County's annual Group Medical Insurance policy would need to be renewed by 1 July 2015. He introduced Mr. Tim McGinn representing Health Planning Associates (HPA) to explain the various options and plans available to the County.

Mr. McGinn stated that HPA had requested quotes for group health insurance from the various providers available in the state of Georgia. Mr. McGinn stated that the County's current provider (Blue Cross/Blue Shield) had returned a quote with a 26.75% increase. He went on to say that United HealthCare had presented a plan which closely mirrored the County's current plan with an increase of 3.33% over current costs. After consideration based on those quotes (see attachment) Mr. McGinn and Mr. Kelly recommended the Board select United Health Care Plan 8B-F with the 3.33% increase over the current plan.

There was much discussion and questions pertaining to the various nuances between the available plans.

Before making any decision on the Group Health Plan the Board took up the conversation of the renewal of the Group Voluntary Dental Plan. Mr. McGinn provided the Board with five (5) options with plans that mirrored the current plan being provided by MetLife. That plan was quoted with at 13.34% increase upon renewal. After consideration based on those quotes (see attachment) Mr. McGinn and Mr. Kelly recommended the Board select the Humana Plan with a 3.70% decrease.

After some discussion Mr. Spillers made a motion to select the HUMANA Plan for the Group Voluntary Dental Coverage. Mr. Blasingame seconded and the motion carried 5-0.

Mr. Spillers made a motion to select the United HealthCare plan #8B-F with the 3.33% increase for the Group Health Insurance Plan. Mr. Braswell seconded and the motion carried 5-0.

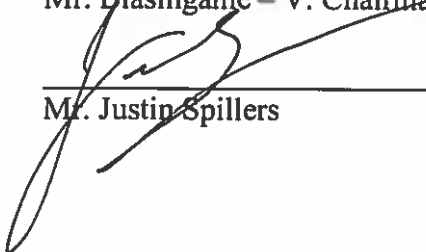
